

## EXTENDING A PERIOD – 2007

**Unless otherwise stated or implied, the following assumptions apply: (a) Time expires during the down and (b) The penalty is accepted.**

#	PLAY	RULING
1	4th and 14 on A's 48. A18 intentionally grounds the ball on A's 41. The pass was thrown to save loss of yardage.	If the penalty is declined and this is the first or third period, start the next period with B's ball, 1st and 10, on A's 41. If the penalty is accepted, it would still be B's ball, 1st and 10, on A's 41 but the period is extended.
2	4th and 14 on A's 48. A49 advances to B's 32. B62 commits a personal foul during A49's run.	A's ball, 1st and 10, on B's 17. Extend the period.
3	4th and 14 on A's 48. A49 advances to B's 32. B62 removes his helmet (noncontact foul) during A49's run.	Penalize as a dead ball foul. A's ball, 1st and 10, on B's 17. The period is not extended.
4	4th and 14 on A's 48. A49 advances to B's 42. B62 removes his helmet (noncontact foul) during A49's run.	A49 did not make a first down. B's ball on B's 27. The period is not extended.
5	4th and 14, on A's 48. A49 advances for a touchdown. B62 commits a personal foul during A49's run.	A's ball, try, on B's 1-1/2 or Team A may elect to enforce the penalty on the succeeding kickoff except when time expires in the fourth quarter. The period would be extended only for the try. [2002]
6	4th and 14 on A's 48. A49 advances for a touchdown. B62 commits a holding foul during A49's run.	The penalty is declined by rule. A's ball, try, on B's 3. The period is not extended except for the try.
7	4th and 14 on A's 48. A49 advances for a touchdown. B62 incidentally grasps A57's face mask during A49's run.	The penalty is declined by rule. A's ball, try, on B's 3. The period is not extended except for the try.
8	4th and 14 on A's 48. B84 intercepts a legal forward pass and is advancing at A's 24 when an inadvertent whistle sounds. During the down, there is no foul.	Team B may elect to replay the down. Team B will elect to take the ball on A's 24. Extend the period.
9	4th and 14 on A's 48. B84 intercepts a legal forward pass and is advancing at A's 24 when an inadvertent whistle sounds. During the down, A78 commits a holding foul on A's 44 prior to the interception.	If the penalty is accepted, it would be A's ball, 4th and 24, on A's 38. Team B could, but will not, elect to replay the down at A's 48. Team B will elect to take the ball on A's 24. B's ball on A's 24. Extend the period.
10	During an accepted successful try after time expires in a quarter, B62 commits a roughing the kicker foul.	The game is over if this is the fourth quarter and the score is not tied. Penalize on the succeeding kickoff (or extra period) if not the fourth quarter. The period is not extended.

## EXTENDING A PERIOD – 2007

**Unless otherwise stated or implied, the following assumptions apply: (a) Time expires during the down and (b) The penalty is accepted.**

#	PLAY	RULING
11	2nd and 12 on A's 8. A12 is sacked on A's 2. A63 holds in A's end zone. The penalty is accepted.	The period is extended although no yardage is enforced on the free kick. The safety is the result of acceptance of a penalty.
12	4th and 14 on A's 48. B37 intercepts a legal forward pass and advances to A's 31. A49 is illegally in motion and B43 holds prior to the interception.	Offsetting fouls. Replay the down. Extend the period.
13	4th and 14 on A's 48. B37 intercepts a legal forward pass and advances to A's 31 where he is downed. B43 holds on B's 42 during B37's run. The penalty is accepted.	B's ball on B's 32. Extend the period.
14	4th and 14 on A's 48. B37 catches A4's punt on B's 16 and advances to B's 47 where he is downed. B86 holds on B's 46 during the punt. The penalty is accepted.	B's ball on B's 8. Extend the period.
15	4th and 14 on A's 48. B37 catches A4's punt on B's 16 and advances to B's 47. Team A had an illegal formation. B86 holds on B's 46 during the punt.	Team B could elect offsetting fouls and replay the down. Extend the period. If Team B declines offsetting fouls and Team A accepts the holding penalty, it is B's ball on B's 8. Extend the period. If Team B declines offsetting fouls and Team A declines the holding penalty, the period ends.
16	4th and 14 on A's 48. B37 catches A4's punt on B's 16 and advances to B's 47. Team A had an illegal formation. B96 was offside. B86 holds on B's 46 during B37's runback.	Offsetting fouls. Replay the down. Extend the period.
