

PENALTY ENFORCEMENT (Running Plays) - 2007

#	PLAY	RULING
1	2nd and 6 on A's 10. QB A18 hands the ball off to running back A33, who runs to A's 18 where he is tackled. A70 held on A's 8.	A33's run ended beyond the neutral zone. The spot of A70's holding foul, A's 8, is behind the previous spot, A's 10. The 10-yard penalty is enforced half the distance from the previous spot, A's 10. A's ball, 2nd and 11, on A's 5.
2	2nd and 6 on A's 10. QB A18 hands the ball off to running back A33 on A's 4. A33 is tackled on A's 7. A70 held on A's 8.	A33's run ended behind the neutral zone on A's 7. The 10-yard penalty for the holding foul by A70 would be enforced from the previous spot, A's 10. Team B will decline the penalty. A's ball, 3rd and 9, on A's 7.
3	2nd and 6 on A's 10. QB A18 hands the ball off to running back A33 on A's 4. A33 is tackled on A's 18. A70 held in the end zone.	It makes no difference if A33's run ended behind or beyond the neutral zone. The holding by A70 occurred in A's end zone. The penalty will be accepted. Safety. Team B is awarded two points. A's ball, free kick, from A's 20.
4	2nd and 6 on A's 10. QB A18 hands the ball off to running back A33, who runs to A's 9, where he is tackled. A70 held in A's end zone.	It makes no difference if A33's run ended behind or beyond the neutral zone. The holding by A70 occurred in A's end zone. The penalty will be accepted. Safety. Team B is awarded two points. A's ball, free kick, from A's 20.
5	2nd and 3 on A's 27. Scrambling QB A18 crosses the line of scrimmage and runs to A's 28. He then reverses his field and, finding an open receiver, throws a forward pass from A's 26 to A80, who is tackled immediately on A's 29. A70 held on A's 23.	A forward pass was thrown by A18 after being in possession of the ball beyond the neutral zone during the down. This is an illegal forward pass and carries its own penalty. The penalty is five yards from the spot of the foul and a loss of down. The holding foul occurred during a running play involving an illegal forward pass and would be enforced from the previous spot. Acceptance of the holding penalty would result in A's ball, 2nd and 13, on A's 17. Team B will most likely accept the penalty for the illegal forward pass. A's ball, 3rd and 9, on A's 21.
6	2nd and 8 on A's 7. QB A18 drops back into the end zone looking for an open receiver and then fumbles. Back A33 picks up the ball in the end zone and is downed on A's 18. During A8's fumble, B33 held A8 in A's end zone.	There is only one running play during the down by rule since A8's run ended behind the neutral zone. The 10-yard penalty for the holding foul by B33 is from the end of the run associated with the running play, A's 18. A's ball, 1st and 10, on A's 28.

7	2nd and 5, on A's 6. QB A14 fumbles in A's end zone. A76 recovers the bouncing ball on A's 12 while grounded. A63 blocks B90 in the back on A's 2 during the down.	A14's run ended behind the neutral zone in A's end zone. The basic enforcement spot is the previous spot, A's 6. Acceptance of the penalty results in A's ball, 2nd and 8, on A's 3.
8	2nd and 5 on A's 6. QB A14 fumbles on A's 12. A76 recovers the bouncing ball on A's 4 while grounded. A63 blocks B90 in the back on A's 8 during the down.	The run ended beyond the neutral zone on A's 12. The basic enforcement spot is the end of the run, A's 12. The spot of the foul, A's 8, is behind the basic enforcement spot and in advance of the previous spot. The penalty is enforced from the spot of the foul, A's 8. It will be A's ball, 2nd and 7, on A's 4.
9	2nd and 5 on A's 6. QB A14 fumbles on A's 4. The ball rolls forward and out of bounds on A's 8. A63 blocks B90 in the back on A's 2.	The ball is returned to the spot of the fumble, A's 4. The run ended behind the neutral zone on A's 4. The basic enforcement spot is the previous spot, A's 6. The penalty is enforced from the previous spot, A's 6. It will be A's ball, 2nd and 8, on A's 3.
