

INTENTIONAL GROUNDING - 2007

#	PLAY	RULING
1	1st and 10 on the 50. QB A16 is scrambling outside the pocket and throws a forward pass from A's 44. The pass hits ineligible receiver A67 in the back on B's 48 and falls incomplete. No eligible Team A player has a reasonable opportunity to catch the ball.	Incomplete legal forward pass. The pass landed beyond the neutral zone. If A67 was downfield before the pass was thrown, an ineligible receiver downfield foul would occur.
2	1st and 10 on the 50. QB A16 is scrambling outside the pocket and throws a forward pass from A's 44. The pass hits ineligible receiver A67 in the back on A's 49 and falls incomplete on B's 48. No eligible Team A player has a reasonable opportunity to catch the ball.	Incomplete legal forward pass. The pass landed beyond the neutral zone.
3	1st and 10 on the 50. QB A16 is scrambling outside the pocket and throws a forward pass from A's 44. The pass hits ineligible receiver A67 in the back on A's 49 and is caught by eligible receiver A88 on B's 48. A88 is downed on B's 42.	Legal. Completed legal forward pass. NOTE: There cannot be an ineligible receiver downfield foul nor a pass interference foul since the pass did not cross the neutral zone.
4	1st and 10 on the 50. QB A16 is scrambling outside the pocket and throws a forward pass from A's 44. The pass hits ineligible receiver A67 in the back on A's 49 and falls incomplete near eligible receiver A88 on (a) A's 48; or (b) B's 48.	Legal. An eligible Team A player has a reasonable opportunity to catch the ball.
5	1st and 10 on the 50. QB A16 is scrambling outside the pocket near the sideline, returns to the pocket, and throws a forward pass from A's 44. The pass falls incomplete on B's 48. No eligible Team A player has a reasonable opportunity to catch the ball.	Incomplete legal forward pass. The pass landed beyond the neutral zone. A16 had been outside the pocket before he threw the pass.
6	1st and 10, on the 50. QB A16 is scrambling outside the pocket and throws a forward pass from A's 44. Ineligible receiver A67 attempts to catch the pass on B's 48 but muffs the ball and the pass falls incomplete. No eligible Team A player has a reasonable opportunity to catch the ball.	Illegal touching. Incomplete legal forward pass. The pass landed beyond the neutral zone.

#	PLAY	RULING
7	1st and 10 on the 50. QB A16 is scrambling outside the pocket and throws a forward pass from A's 44. The pass hits ineligible receiver A67 in the back on B's 48 and falls incomplete. No eligible Team A player has a reasonable opportunity to catch the ball. A56 blocked B94 from the neutral zone to B's 45 and remained on B's 45 until the pass was thrown.	Ineligible receiver downfield. Incomplete legal forward pass. The pass landed beyond the neutral zone.
8	1st and 10 on the 50. QB A16 is scrambling outside the pocket and throws a forward pass from A's 44. The pass is caught by ineligible receiver A67 on A's 49 and advanced to B's 38 where he is downed. No eligible Team A player has a reasonable opportunity to catch the ball.	Intentional grounding. Complete illegal forward pass. The pass did not land beyond the neutral zone. Illegal touching can only occur during a legal forward pass.
9	1st and 10, on the 50. QB A16 is scrambling outside the pocket and throws a forward pass from A's 44. The pass is caught by ineligible receiver A67 on A's 49 and advanced to B's 38 where he is downed. Eligible receiver A88 had a reasonable opportunity to catch the ball when A67 made the catch.	Illegal touching. Legal forward pass. An eligible Team A player has a reasonable opportunity to catch the ball.
